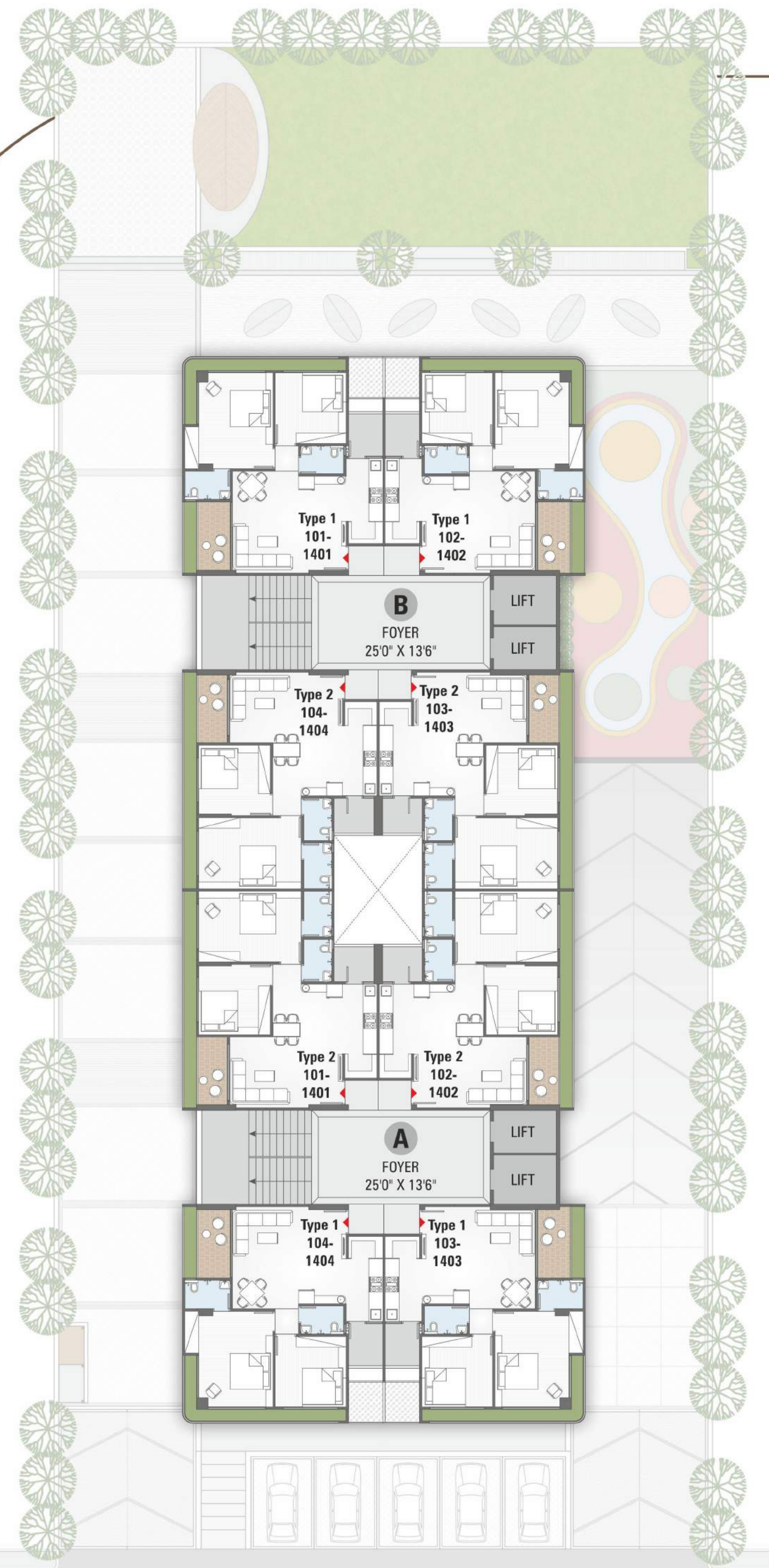

TYPICAL FLOOR PLAN 





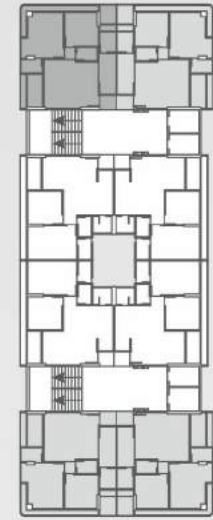

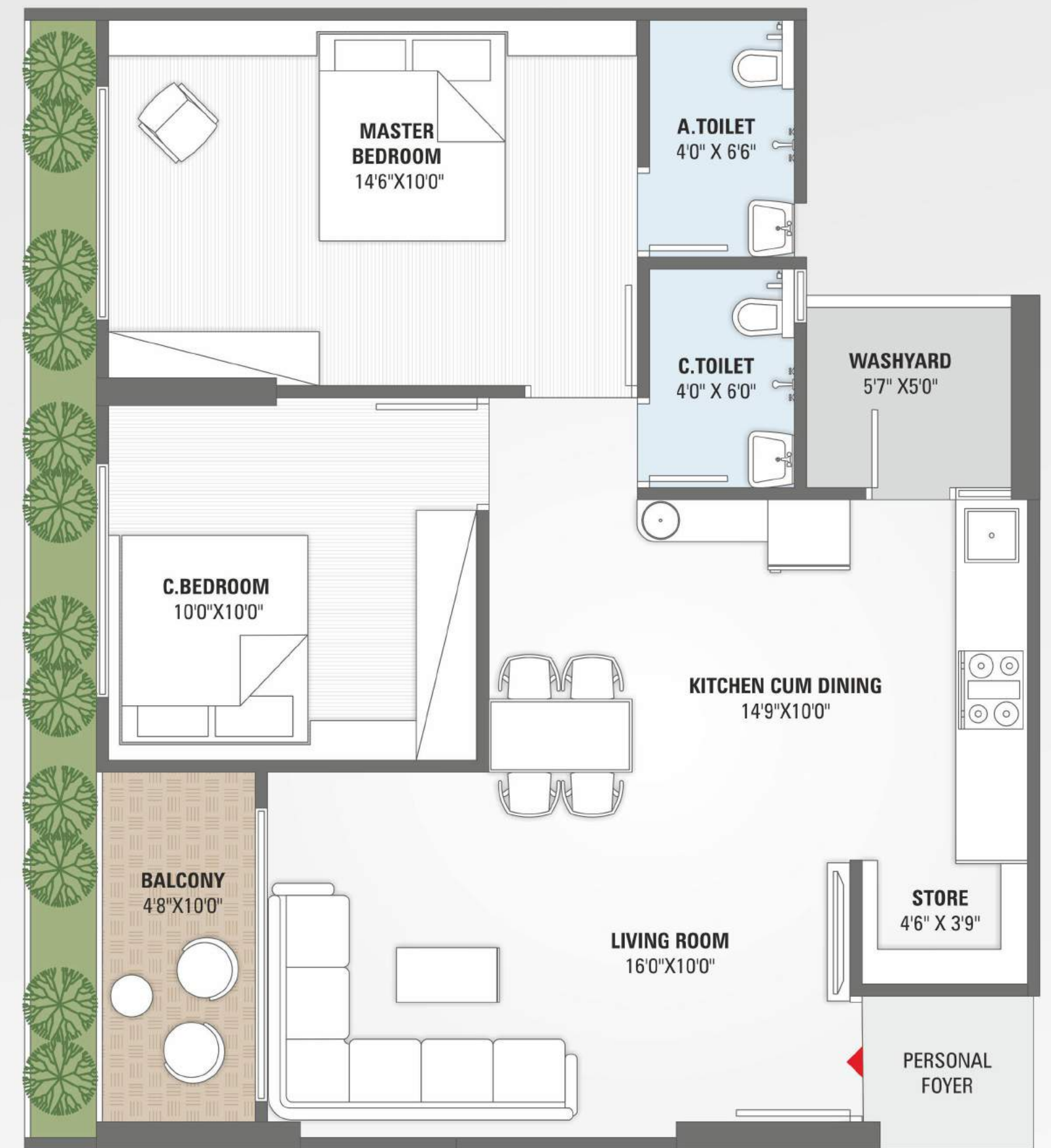
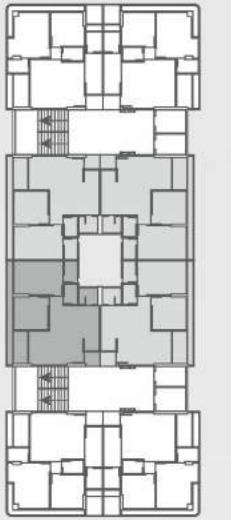
